

### INFORMATION PACKAGE FOR NATIONAL SPEED RECORD ATTEMPTS

Attached are sample documents, which will help you with lodging your claim for your speed record attempt.

We trust these will be of assistance and wish you well with your attempt.

### Check List:

- Previous Record Holders advised as per rule 4-10-7 "Promoting Clubs must notify all other clubs, and the previous year's title-holder, of the date, venue and supplementary regulations for the championship at least 60 days before the event."
- Road Closure Organised ~People available to ensure that no traffic goes through road blocks
- Road Surveyed
- Timing Equipment Tested
- First Aid in Attendance ~Preferably a Doctor
- Fire Protection arranged
- Radio communication available between all officials

## MNZ Manual of Motorcycle Sport Chapter 18 – National Speed Records

- **18-1** The terms 'Drags' or 'Drag Racing' must not be used in any publicity involving MNZ events.
- **18-2** Attempts at National Records may be arranged by the organising club obtaining a Record Attempt Permit from the MNZ Office.
- **18-2-1** Competitors successful in bettering existing records must on the same day file a Record Claim with the Steward in control of the meeting together with the record claim fee.
- **18-3** Following certificates are required and must be forwarded with the record claim to the MNZ Office within (14) fourteen days of the event.
- **18-3-1** Certificate from a surveyor or competent official of the meeting that the course has been measured and found to be correct. (The course must be measured using a surveyor's steel tape).
- **18-3-2** Certificate of gradient (must not exceed one per cent (1%) for the entire course and 100 metres of the approach to the start line).
- **18-3-3** Certificate from the starter that the start was a fair one, that the rider claiming the record did not leave his/her mark before time.
- **18-3-4** Certificate from each of the three timekeepers giving the time recorded by the watch or timer used in any mechanical or electronic apparatus.
- **18-3-5** Certificate from the judges at the finish giving the man placed.
- **18-3-6** Certificate from a member of the Horological Institute, or a qualified watchmaker, that he/she has tested the watches or timers used by the timekeepers and giving the variation, if any, from a standard chronometer.
- **18-3-7** Certificate of a Senior or Regional Co ordinator that he/she has sealed the engine before the machine was taken from the venue and not more than 30 minutes after the last run of the machine.
- **18-3-8** Certificates of measurement from a competent official or engineer, of the bore, stroke, and number of cylinders of the machine. (All measurements to be given in metric measure refer to rule 10-16).
- 18-4 In the case of a sidecar record claim, the weight of the passenger or ballast carried. The minimum weight of a passenger or ballast is sixty (60) kilograms.

- 18-5 On ratification of the record claim, MNZ shall forward to the claimant a record certificate stating the nature of the record and the speed and/or time achieved.
- 18-6 The course shall not be ridden on or cut up in any way that may lessen a rider's chance.
- **18-6-1** The finish shall be clearly marked with two flags.
- **18-6-2** Every effort shall be made to ensure that the full length of the course is clear of spectators or other objects that may jeopardise a rider's safety or chance of success.
- 18-7 Machines may be of any type and any form of streamlining is permitted.

### Timekeeping: 18-8

For national records over distances of less than ten (10) kilometres times shall be kept by three competent officials using some form of automatic apparatus which will be triggered by the interruption, by the competing motorcycle, of a light beam acting on a photoelectric sensor.

- **18-10** No restrictions other than capacity shall be placed on the machine other than those set down for safety.
- **18-11** Flying Start Records
- 18-11-1 Course: The course shall measure at least 3.2 kilometres overall with a minimum of 1200 metres before the start line and after the finish line.

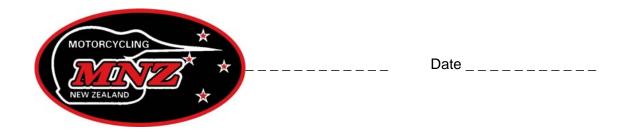

- **18-11-2** The timed strips shall be 400 metres or 440 yards.
- **18-11-3** A rider will be allowed at least three runs a run means a ride in each direction. The return ride for a record time must take place within fifteen (15) minutes of the first ride.
- **18-11-4** The speed will be calculated on the mean time of the best run. The record claim shall state the actual time for each ride, and the mean time for the best run. (Note: mean time is calculated by adding together the times of two consecutive rides, and halving the result).
- **18-11-5** The watch or recording apparatus shall record to at least one fiftieth of a second.
- **18-11-6** A record will not be recognised unless it better the previous mean time by one percent or greater.
- **18-12** Standing Quarter Mile Sprints
- **18-12-1** The course will measure 440 yards between timing points.
- **18-12-2** An adequate run-off area for braking must be provided.
- **18-12-3** Competitors must start from the start line at the first timing point and no part of the motorcycle may be forward of that line.
- **18-12-4** No run-in to the start line will be permitted.
- **18-12-5** Records can be claimed from one-way runs provided that in the opinion of the Steward, there was no material wind assistance.
- **18-12-6** A record will not be recognised unless it betters the existing record by not less than five one hundredths of a second (0.05 seconds).
- **18-12-7** Riders will be allowed at least one practice run.
- **18-12-8** Riders will be allowed three runs per class entered.
- **18-12-9** Competitors must nominated the class entered before the run is timed.
- **18-12-10** A rider's fastest timed fun for the day will only count towards the class nominated before the run.
- **18-13** Where it may be necessary to verify the engine size, the cost of dismantling shall be met by the rider.
